Partial Unit Rate:

Undergraduate (Includes Dental Hygiene): 1-1½ units or over 18 units = \$1,781 per unit, plus fees.

Pharmacy: 1-1½ units or over 20 units = \$1,836 per unit, plus fees.

Graduate: 1-1½ units or over 18 units = \$1,566 per unit, plus fees for 9 units and above.

PAYMENT PLANS

TOTAL UNIVERSITY COSTS - (SCHOLARSHIPS, GRANTS, LOANS) = AMOUNT DUE

Semester Plan (General)	- One payment due by August 1, 2021.
Term Plan (Pharmacy)	- One payment due by August 1, 2021.
Monthly Plan (General)	- Three payments due: August 1, September 1, and October 1.
	- Five payments due: August 1, September 1, October 1, November 1 and December 1.
Monthly Plan (Pharmacy)	- Four payments due: August 1, September 1, October 1, and November 1.

Enrollment in the monthly payment plan requires a Non-Refundable Deferred Fee of \$25 per semester for 3 months and \$75 per semester for 5 months (General).
 Enrollment in the monthly payment plan requires a Non-Refundable Deferred Fee of \$75 per term for 4 months (Pharmacy). Payment plans require online enrollment.

Students must remit their payment for the semester, less any **completed** financial aid (scholarships, grants, and loans) by the payment deadline for the plans listed above. Payments are due on the 1st. Payments not received by the deadline will be assessed a late fee.
